
Happy Holidays and Happy New Year



NOVEMBER: Announcing the "Traveling with Dignity" Act

The CP Unlimited offices in Hudson Valley hosted New York State Senators Peter Harckham (D- District 40) and Rob Rolison (R- District 39) for an important press conference and announcement of Senator Harckham's "Traveling with Dignity" Act that will soon be submitted as legislation in New York State.

The bill mandates the installation of adult changing facilities at venues across New York that can host more than 2,500 visitors. For people with intellectual and developmental disabilities, alongside veterans and seniors, this will mean the ability to access the full program and event at spaces where they previously were not accommodated.


Recognizing Our Catholic Charities Cohort
