RESIDENTIAL SERVICES

A home is the most important, stable element of a fulfilling life. CP Unlimited is one of the most committed organizations providing comprehensive residential services to people with intellectual and developmental disabilities (I/DD), having centered these services when we began supporting people who experienced the conditions of Willowbrook many decades ago.

Today, the Agency operates 112 IRA and ICF residential settings throughout the five boroughs, Yonkers, and the Hudson Valley.

In 2023, the organization supported 490 people living in IRAS and 130 people in an ICF setting in New York City and the Hudson Valley.

Individualized Residential

Alternatives (IRAs) are community based residential homes or apartment settings for persons ranging from 18+ years who have I/DD and designed to enable them to be become more independent, productive, and integrated into their community.



Intermediate Care Facility

(ICF) Sites are homes with 24-hour nursing oversight which build on IRA supports to also offer treatment services, training, and on-site nursing care.



Cutting the Ribbon on CP's Newest Home and First in Yonkers!

CP Unlimited reached new residential horizons in Yonkers, New York- opening our first residential setting in November 2023.

CP leadership joined local partners Tasha Diaz (Majority Leader, Councilwoman, District 3) and Yonkers Deputy Mayor Tony Landi, alongside a representative from the office of Nader Sayegh (Assemblyman, 90th District), to officially cut the ribbon for this barrier-free residence.

OPWDD SUBSIDY PROGRAM



CP Unlimited's Independent Living Support Service (ISS) supports people with intellectual and developmental disabilities to live in communities of their choice.

To qualify, a person must be enrolled in the Office For People with Developmental Disabilities (OPWDD) program to be eligible for the subsidy. Within this program, persons have the choice of living alone, with roommates, or to continue to live in their current non-certified setting.

With locations in in all five boroughs, in 2023 CP Unlimited supported **75 people in ISS housing.**

COMMUNITY HABILITATION



CP Unlimited's Community Hab. program is a Medicaid-funded, residential program where people with I/DD achieve independent-living goals.

All individuals who are enrolled in Home and Community Based Services (HCBS) are eligible to receive this service and work to attain self-determination with the assistance of a trusted Community Habilitation Specialist. Staff are matched based on the preference of the person served and remain flexible while delivering services in the person's language of choice.

In 2023, the organization helped 95 people receive dedicated Community Habilitation services in New York City and Hudson Valley.

This year, the Agency also added Self-Direction supports to our offerings, providing participants the autonomy and flexibility to self-direct their services, hire their own staff, and make active choices regarding the services that they receive.

DAY HABILITATION SERVICES



The CP Day Hab network is a daily mosaic of music, games, and classes, layered in with inventive and distinctive offerings that promote learning and self-sufficiency.

These innovative options include several exclusive to our Agency including a Pottery Club with the only kiln for people with I/DD, the West Farms Photo Works and Progressive Visions Photo Club, the inspirational M.O.V.E. program, and many more.

In 2023, The Agency delivered programs in New York City and Hudson Valley that enriched the lives of more than 500 people.

Day Hab Without Walls

CP Unlimited participates in the OPWDD Day Habilitation Without Walls program throughout the five boroughs of New York City, offering 73 people in 2023 the ability to integrate into their local community more deeply by accessing events at area businesses, libraries, parks, museums, cultural centers, and more.

In 2023, CP sought to expand our "Without Walls" horizons and created new partnerships to help give back in our shared communities across New York City. At Union Grove Missionary Baptist Church in The Bronx and New York Common Pantry in Manhattan, CP's persons supported are contributing in various capacities. Additional inroads will make 2024 a year where we magnify these efforts.




M.O.V.E. (Mobility Opportunities via Education/Experience)

M.O.V.E. is an innovative activity-based program that helps people acquire the motor skills needed for sitting, standing, walking and transitioning through specialized equipment and physical activity.

We are proud to be the only provider offering M.O.V.E. to adults with I/DD in New York City.


In 2023, plans were made to expand the M.O.V.E. program from Staten Island to The Bronx and the Hudson Valley to grow its dramatic impact.



Adult Education Series

Students in the CP network enjoy ongoing opportunities to improve personal and professional development skills while attending the Adult Education Series throughout the year. Participants help direct the subjects studied and are supported by their Direct Care staff to transfer their knowledge to real life situations.

In 2023, CP Unlimited supported 42 people with courses and introduced curriculum to teach ASL (American Sign Language), in addition to a full slate of courses on Money Management, Math, Using Technology, Cooking and Baking, Letter Writing, the 'Patrick Emproto Book Club' and much more!

VOCATIONAL AND EMPLOYMENT SERVICES



Supported Employment (SEMP) and ACCES-VR

CP Unlimited helps persons supported to join the job market by providing employment readiness trainings and assisting with interviews and ongoing skills development. Through this program, new professional horizons are envisioned, and plans created to achieve those goals.

The Supported Employment Program (SEMP) through OPWDD offers employment opportunities for the people we support. The program is administered through Adult Career and Continuing Education Services-Vocational Rehabilitation (ACCES_VR), as well as CP's Employment Training Program (ETP).

This year, CP Unlimited added another person supported in our Fresh Food Box program as a Site Coordinator which now allows two from the CP network to increase their independence. We also placed eight persons supported in various positions at local chains like Dollar Tree and independent cleaning, maintenance, and dining establishments, alongside six Diagnostic Vocational Evaluations (DVE) for the ACCES-VR program.

Peer Companion Program (Supported Employment)

As part of our SEMP program, two of the individuals supported by CP Unlimited are taking big steps towards independence while working with people with I/DD.

Angel works out of CP Unlimited's Caldwell residence in Queens, and escorts individuals who use wheelchairs to area stores, parks, libraries, and other settings for joyous events and daily experiences.

Jason is a Peer Companion at CP's Day Hab Without Walls setting working to assist fellow participants with their vocational skills during the program.



Smile Farms

For the past several years, people supported by CP Unlimited have enjoyed growing more than just a great partnership!

Two of the people we support work full-time in the greenhouses at our Cora Hoffman Center on Staten Island tasked with helping plant, harvest, and distribute the peppers, kale and more.

Set up by Smile Farms, the non-profit arm of 1-800-FLOWERS, the peppers are used in the organizations' delicious "Heat with Heart" hot sauce while the kale and other crops are used in fine-dining restaurants across New York City owned by Tom Colicchio.

ARTICLE 16 CLINICS

Physical Therapy | Occupational Therapy Speech Therapy | Psychotherapy and Testing

CP Unlimited maintains a network of six OPWDD-certified clinics in New York City and Hudson Valley, which counted **932 Admissions**, with **14,606 Article 16 visits**, in 2023. Owing to efforts at expanding capacity within the clinics to meet demand—especially amongst our psychotherapists—the Agency was able to count a **30 percent increase in visits** from 2022.

Our clinics are held in warm, welcoming environments where the promotion of independence and optimal function is always the focus. We encourage our patients to set new goals and build on their past achievements, expanding their capabilities while enhancing strength.

Limitless Health Foundation and Kindful Movement

New for 2023 is the introduction of the Kindful Movement program for our Day Hab participants. The approach to movement uses kinesthetic empathy to understand the needs of the participants and explores safe constructive ways to move the body at the individual's physical, intellectual, and/or emotional development.

Thanks to an additional grant from the New York State Agency of Day Service Providers, CP was able to include additional equipment to facilitate participation in these helpful classes.

TRAINING & QUALITY IMPROVEMENT

Training

CP Unlimited has always maintained a robust training program, both at the onset of work for new employees and in creating and sharing new plans once onboard. Building on standard state and federal requirements, the organizational vision is to consistently engage our community with educational opportunities that enhance personal and professional skills. As a result, our team is better able to help those we support while maintaining awareness of new trends in the field.

2023 was a significant year where we expanded our horizons as the result of new offerings, awards, and engagements.

CP Unlimited counted nearly **16,000** courses completed by our team, with an additional **1,400** completed by volunteers, contractors, and others helping elevate the level of education and talent amongst both our workforce and the I/DD field. The Agency also developed and added **16** new courses to our online Litmos training library.

Further trainings in CPR were provided to nearly **450** staff with another **135** taking part in AMAP (Medication Administration) courses to deepen abilities to be of comprehensive service to persons with I/DD.



New Partnership with the National Alliance for Direct Support Professionals (NADSP) Boosts Skills for Front-Line Supervisors and Direct Support Professionals

In March of 2023, CP Unlimited was selected to participate in a 3-year national pilot program offering credentialing of Front-Line Supervisors and Direct Support Professionals.

In addition to the opportunities for recognition, learning, and reflection, participants in the program receive bonuses upon completing their certification. Of the 25 seats offered, four are filled by Front Line Supervisors and nine by DSPs from CP Unlimited.

Quality Assurance and Quality Improvement

Quality Assurance and Quality Improvement is an essential department at CP Unlimited. Data Analytics is at the core of the department. Advancements made in maintaining and monitoring data allow the field to have a better understanding of areas requiring attention in order to deliver the best services possible.

To this end, in 2023 a full implementation of an Incident Management dashboard allowed our team to provide real time data to the field to support improvements within Incident Management. Given the success and benefits seen within Incident Management, the Agency also initiated work on the creation of a Citation Management Dashboard that, once complete, will provide a more efficient and responsive way to analyze internal and external audit information.

Efforts were also made to update our bi-annual Satisfaction Survey process for our Residential, Day Hab, Community Hab., and Vocational programs with an emphasis on sustaining improvements made in 2019 and 2021.

We also honored those who have been with the organization for the five years of operation of our Hudson Valley Division and the employees who came to CP Unlimited when we acquired Catholic Charities in 2016.

The Agency was proud to recognize nearly 1,000 of our CP Family at these special programs in 2023.

SIGNIFICANT GRANTS AND PARTNERSHIPS

Expanding Mobility Transport Services in NYC and the Hudson Valley

Cerebral Palsy Transport, the transport division of Constructive Partnerships (CP) Unlimited, received \$4.8M from the New York State Department of Transportation in 2023.

Provided under the Federal Transit Administration's (FTA) Enhanced Mobility of Seniors and Individuals Section 5310 Program, the grant allows the transport division to modernize and grow our fleet by six vehicles with capacities between 6-8 wheelchairs and 20-36 ambulatory people with disabilities.

An Expanded Grant from the Mother Cabrini Health Foundation

The Foundation was encouraged by the popularity and reach of our complimentary wheelchair clinics for people with I/DD, veterans, and seniors in 2023: the Agency originally projected we would be able to reach 250 people who use wheelchairs, but we were able to impact over 1,500 people.

The \$1.5M contribution will empower CP Unlimited's Rehabilitation Department to primarily offer more frequent and mobile wheelchair clinics. The increased funding will also permit CP to service power wheelchair users, purchase an additional wheelchair cleaning machine for our Nassau affiliate, and launch a train-the-trainer program for I/DD partners statewide.

A Local Connection with a Broad Impact: The Verrazano Kiwanis Club

One serendipitous conversation has led to a long-term partnership with the Verrazano Kiwanis Club- a local, Staten Island affiliate of the national service group.

With their commitment in 2023, the Agency was the beneficiary of an exotic and collector car show, allowing us to purchase additional specialized mobility equipment for M.O.V.E. (Mobility Opportunities via Education/Experience)- a transformative program helping people with disabilities on Staten Island expand personal mobility and accessibility via equipment and training.

ACTIVISM AND ADVOCACY

Traveling with Dignity Act

Bill #7697, introduced by NYS Senator Peter Harckham (D- District 40) at CP Unlimited's Hudson Valley affiliate, mandates the installation of adult changing facilities at venues across New York that can host more than 2,500 visitors. For people with intellectual and developmental disabilities, alongside veterans and seniors, this will mean the ability to access the full program and event at spaces where they previously were not accommodated.

The issue was brought to Senator Harckham's attention by CP Unlimited self-advocates and championed by his office.
